



## iPad Mini 'One to One' Donation Scheme – Parental Response Form

Our website carries full details of how the iPad Mini 'One to One' donation scheme operates. Key points to note are:

- This is not a lease or a rental scheme it is a **donation scheme** (which is non-profit). We are asking parents to donate £9 per month for 36 months to our partner charity - the Learning Foundation.
- The school will also provide a case, insurance cover (subject to a £40 excess payment per claim), iTunes education app download codes, maintenance and software support.
- At the end of the scheme you can either return the iPad Mini and start again, or pay the market value and keep the device.
- **Parental contribution is a charitable donation towards the scheme, not a payment towards the iPad.**
- The amount we are suggesting does not cover the full cost of running the scheme; additional money will be provided from school funds and grants that we may win from other sources.
- Advantages

- Monthly donations so cost is spread
- Gift Aid and monthly donations ensure that the scheme is both sustainable and open to all
- iPad Mini is insured for damage with repair arranged by the school\*
- Case is provided
- Access to apps paid for by the school

\*Whilst everyday accidents happen, the insurer will reject persistent, careless or malicious damage claims should they feel this is the case. Students must ensure they take care of their device to avoid this. The iPad **must** be kept in the case provided by the school at all times.

- The iPad is not insured for loss.
- Ownership: The iPad mini will remain the property of Rossett School until the end of the three year period. If you wish to take ownership at this time there will be the opportunity to do so by making a payment to school which will reflect the market value at that time. We currently estimate this to be £40.
- If a student leaves the school before the end of the three years then it will still be possible to take ownership of the iPad Mini. The market value will reflect the age of the device at that time.
- Donations are paid to the Learning Foundation which is a registered education charity.
- It is also very important that we receive tax relief which helps to make the scheme viable and would request that you sign the gift aid box on the donation form.
