

16 to 19 Tuition Fund Statement

The Department for Education announced a small amount of funding to support students whose learning was disrupted as a result of the COVID pandemic. This 16-19 Tuition Fund is available to all 16 to 19 education providers who applied and is ring-fenced for 16 to 19 small group tuition and tutoring.

The funding can be used to support small group tuition for 16 to 19 students in English, Maths, and other courses where learning has been disrupted. The guidance indicates that the supported students must be on a 16 to 19 study programme and who have not achieved grade 5 or above in GCSE maths and/or English by age 16. All will be on a 16 to 19 study programme. The subjects covered in the tuition will not be limited to English and Maths but will be identified according to need and existing programmes.

Funding is provided for the following students:

- Those with an Education, Health and Care (EHC) Plan or SEND
- Those who have a grade 4 or below in GCSE Maths and/or English
- Students where it is evident school closure has had a significant detrimental impact on progress and attainment.

Temple Moor High School has been allocated £2,009 from the 16-19 Tuition Fund. We are committed to supporting targeted students in mitigating against the impact of the Covid -19 pandemic. Tuition Support offered will be based on individual student need, clear learning goals, expectations, and evidenced based outcomes.

The breakdown of our proposed spending is below.
