

ROSSETT SCHOOL: iPads for Learning Consent Form

Please complete and return this form to the iPad Administrator, via Main Reception, before a school iPad can be issued. This agreement applies to **all iPads used in school**, including Scheme iPads and Loan iPads.

Agreement

To help keep everyone safe and ensure technology is used responsibly, I agree to the following:

- I understand that if I am issued with a **Scheme iPad** or **Loan iPad**, it must remain in its protective case at all times. The case may only be removed by a member of the IT Services Team or the iPads Team.
- If my iPad is fitted with a screen protector, I understand that it must remain in place. It may only be removed by a member of the IT Services Team or the iPads Team.
- I will only access school systems and my device using my own school-issued username and password, and I will keep my login details confidential.
- I will not attempt to access another person's device, account, files or storage, or interfere with another person's work.
- I will use my iPad for schoolwork and homework.
- During the school day, I will not use my iPad for activities that are unrelated to learning unless authorised by a member of staff.
- I will use the iPad responsibly and will not behave in any way that could damage the device, other ICT equipment or the school's IT systems.
- I will communicate online in a polite, respectful and responsible manner.
- I will not share my home address, telephone number or other personal information online, or arrange to meet anyone I have contacted online, unless I have permission from my parent/carer and the school.
- I will report any inappropriate, upsetting or concerning material or messages to a member of staff immediately.
- I will bring my iPad to school every day, fully charged and ready for learning.
- I understand that the school may inspect my iPad, its contents and files, and monitor my use of the internet and school systems while on the school network.
- I understand that my use of the iPad is subject to the school's **Acceptable Use of ICT Policy**.
- I understand that the use of **Virtual Private Networks (VPNs)** is not permitted on the school site or while connected to the school network.
- I understand that a parental contribution is required towards repair costs for accidental damage, whether the iPad is a Scheme iPad or a Loan iPad. This contribution is similar to an insurance excess and is detailed in the school's **iPad Repair Service**, available on the school iPad webpages.

Additional Information for Scheme iPads

I understand that:

- The iPad remains the property of Rossett School until it is offered for purchase.
- Students may be offered the opportunity to purchase their iPad in Year 11 if they are leaving the school after GCSEs.
- A payment must be made to the school if I wish to keep the device.
- If I leave the school before these points, the iPad must be returned and cannot be purchased.

Additional Information for Loan iPads

I understand that:

- The iPad has been loaned to me by Rossett School.
- It remains the property of the school at all times.
- It must be returned when I leave the school or if I join the School iPad Scheme.
- Loan iPads are not available for purchase.
