iPads for Learning Scheme – Year 12 2024 Programme

This year, our iPads for Learning scheme for Year 12 students will follow the same format as that being used at other Red Kite Learning Trust Schools where the iPad Programme it has been long-established.

The scheme:

- ensures equality of access to a one-to-one device at school and at home
- prepares students for working and living in a digital age
- supports self-led research and problem solving
- improves the quality of feedback, home learning and collaboration
- provides new and innovative ways for students to learn
- organises learning resources and acts as a digital tool for learning.

It has additional benefits of:

- improved security and controls for parents/carers and the school
- improved measures to keep students safer online

The Year 12 iPad Scheme 2024-2026

The current scheme runs from Year 12 to the end of Year 13, after which you will be able to buy the iPad for private use.

The scheme covers 20 months in total at a fixed contribution rate set at the start of the scheme. For 2024-2026 scheme, the cost is **£17 per month**, payable by Direct Debit.

Your support allows us to continue the scheme. We therefore politely ask all Parents/Carers to commit to donating the full amount over the full term of the scheme.

Your child will receive:

- A brand-new and boxed 10th Generation iPad (containing an Apple charger and charging cable)
- A protective case (that should only be removed by a member of the IT Services/iPads team)
- Apps required for lessons under the Apple for Education licence. Please note, you will not have access to these apps if you subsequently buy the iPad for private use
- Access to the school's Repair Service, which requires a **parental contribution towards repair costs at the prevailing rate shown on the school web-site.**

Scheme Expectations

All of our schemes are governed by an iPads for Learning Agreement that can be found with this invitation letter. A copy of all documentation will be made available via the school's website as soon as possible. Please read the Agreement carefully as, by joining the scheme, you are agreeing to its Terms & Conditions.

The scheme is a Gift-Aided scheme. Gift-Aid rules mean the iPad remains the property of the school until optionally purchased from us at the end of Year 13. As such, iPads can only be repaired through the school's Repair Service and not through any third-party repair service. Repair fees are separate from the Gift Aid scheme and payable in advance, according to the Repairs Procedure. Should your child leave us before the end of the scheme, they must return their iPad to school. This helps us to keep the running costs of the scheme to a minimum.

Students can only remain in the scheme if they adhere to the current rules and expectations (including repairs). If they do not, they will still have access to a **Leave at School iPad**, which the student will not be able to take home at the end of each day. This helps prevent further damage and minimises the cost to parents/carers and school.

Financial Support

The rules governing Gift-Aid schemes dictate that all donations are voluntary and no student should be excluded from having access to an iPad for financial reasons. We offer limited assistance to those households who cannot afford to donate or who have difficult financial circumstances. If you are unable to commit to donating the full amount over the full term of the scheme, or if your circumstances change at any point, please contact the iPads Administrator at rsipads@rs.rklt.co.uk to discuss the options available.

Joining the Scheme

You do not have to join this scheme as Sixth Form Students can provide their own iPad for use instead. If you choose to provide your own iPad for use you will still need to send in the iPads Consent form attached to this letter, before the device can be connected to the school network.

If you wish to join our scheme please complete the steps below **by Friday 19 July 2024**. After after this date we cannot guarantee that an iPad will be available for your child in September.

Even if you are unsure that your child will start in September/you decline their place/you are waiting for exam results to make a final decision, please sign up so that your child isn't disappointed. Your DD is covered by the Direct Debit Indemnity guarantee and if you child does not start in September or your child changes their mind about joining us, the DD can be cancelled and any money paid would be refunded.

1. Please set up a direct debit with the Learning Foundation **starting on 5 October 2024 for £17 per month over 20 months**, using the link below:

2. Please also submit an iPad Consent form as soon as possible. This can be found at the end of the invitation letter.
3. Please read the attached iPad for Learning Agreement

Once you have set up your DD and returned the iPad consent form to the Finance Office an iPad will be ordered for your child.
